



KENYA NATIONAL SPELLING BEE ONLINE COMPETITION

TERMS AND CONDITIONS

1. The 'Company' is **Kenya National Spelling Bee Limited** whose registered office is at [The Odyssey, 84 Muthithi Rd. Westlands.](#)
2. The competition is open to Kenyan Learners aged **14 years and below** except those of employees of the company and their close relatives and anyone otherwise connected with the organisation or judging of the competition.
3. There is no entry fee and no purchase necessary to enter this particular competition.
4. By entering the competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.
5. Route to entry for the competition and details of how to enter are via the company's official [Facebook page](#) (Kenya National Spelling Bee) and the [website](#) (www.kenyaspellingbee.com).
6. Only one entry will be accepted per person each week. Multiple entries in one week from the same person will be disqualified.
7. The competitions run every Monday to Friday each week. Draws for each competition will be done every Saturday and winners announced the same day. After Saturday, no further entries to the competition will be permitted. Competitions that will run for more than a week will be announced.
8. No responsibility can be accepted for entries not received for whatever reason.
